Chairperson's Report

The Gunaikurnai Traditional Owner Land Management Board (the Board) reached a number of significant key milestones during 2017/18.

The final draft Joint Management Plan (draft JMP) was completed and approved by the Secretary of the Department of Environment, Land, Water and Planning (DELWP) in October 2017 for public release and submissions. A two month public consultation process was completed and feedback from submissions was used in developing the final JMP. During this period the Board invited key stakeholders, user groups and the public to view the draft JMP and provide submissions to the Board. The Board met again with Gunaikurnai people, a number of key groups and also held public drop in sessions in a number of towns throughout Gippsland. A total of 39 submissions were received, all of which provided encouraging support for joint management as well as providing refined factual information to be included in the draft JMP.

We continued to strengthen our communication and engagement processes by progressing in accordance with our integrated communication and engagement strategy. This ensured coherency across each element and each stage of the JMP's development through to its proposed launch. We continued to maintain and strengthen our close working relationship with our partners and, in particular, working closely with GLaWAC to ensure the work of the Board now and in the future is a true partnership that delivers the results and aspirations of the Gunaikurnai community. We have continued to support and encourage key interagency partnerships through joining the Gippsland Environment Agencies Group and signing up with their interagency partnership agreement.

While working on the completion of the draft JMP the Board continued to support and encourage priority projects that: reflect the shared objectives of joint management; align with Gunaikurnai Land and Waters Aboriginal Corporation's (GLaWAC) joint management priorities; and support the joint management implementation partnership. Key projects for the year included the on-going support for the priority joint management implementation projects being delivered by Parks Victoria in conjunction with GLaWAC as well as initiating a JMP Implementation Plan project to work with individual partners to determine their views on priority JMP activities/actions for implementation, scheduling and preferred project lead over six years following approval of the JMP.

The Board has maintained its support and guidance for the interim Knob Reserve Committee of Management, with members from GLaWAC, the Board and DELWP. We have also supported and conducted preliminary consultation with local user groups of the reserve to assist in the development of the JMP and to assist in committee decision making.

The Board has maintained its hosting arrangement with the East Gippsland Catchment Management Authority (EGCMA) which has been invaluable in helping the Board complete the JMP development task and maintain its governance and compliance obligations. This arrangement and relationship will continue to be important as we progress to implementing the JMP in the next reporting period.

The Board looks forward to submitting the draft JMP to the Secretary of DELWP in July 2018 to seek agreement to it and subsequent referral of the agreed JMP to the Minister for Energy, Environment and Climate Change for consideration and approval.

I would like to extend my appreciation to my fellow Board members and staff, the GLaWAC Board and its staff, for their endeavours over the last year which enabled us to finalise the JMP development journey. I would also like to acknowledge the importance of our partner agencies who continue to embrace the opportunity to work collaboratively with the Board. I look forward to further developing these unique partnerships as we move ahead with priority implementation actions for the ongoing benefit of all Gunaikurnai people and all Victorians now and into the future.

Report of Operations

1. Year in Review

1.1. VISION, MISSION, VALUES

Vision

The vision of the Gunaikurnai Traditional Owner Land Management Board (the Board) is:

"Empowered and respected Gunaikurnai actively managing and caring for their land and water for the enjoyment of all people."

Mission

The Board's adopted mission is to:

- actively protect Gunaikurnai culture, land and waters and bring strength, knowledge, skills and innovation to that role
- support Gunaikurnai to maintain and build their strong connections to joint managed lands
- generate greater employment and economic development opportunities for Gunaikurnai
- use Gunaikurnai traditional knowledge to set and guide strategic and operational direction for joint managed lands; and
- build respectful relationships and enduring partnerships to protect and enhance Gunaikurnai joint managed lands.

Values

The values and principles the Board operate by are:

- we encourage and value leadership by example, creativity and new ideas;
- we serve the good of all Gunaikurnai
- we are persistent in supporting the journey for Gunaikurnai towards self-determination and social justice
- we listen to understand all views before judgement and decision making
- we demonstrate courage and integrity in all we do
- we encourage and value teamwork
- we are empowered to respectfully challenge and speak with candour and be committed to resolving conflict
- · we value strong and enduring partnerships; and
- engaging and consultative processes are integral to the way we work.

1.2. MANNER OF ESTABLISHMENT AND RESPONSIBLE MINISTERS

The Board is established under s82B(1) of the *Conservation Forests and Lands Act* 1987 (Vic) to give effect to, and regard to the *Gunaikurnai Traditional Owner Land Management Agreement* dated 22 October 2010.

The responsible Minister during the 2017/18 reporting period was the Hon Lily D'Ambrosio, Minister for Energy, Environment and Climate Change.

1.3. NATURE AND RANGE OF SERVICES PROVIDED

What the Board does

The Board's role is to:

- set and guide strategic direction for the joint management of the Appointed Land of the Board;
- collaborate with the State of Victoria (the State) and relevant State land managers in the management of the Appointed Land and enable the knowledge and culture of the Gunaikurnai people to be recognised in the management of the Appointed Land; and
- foster employment and economic development opportunities for Gunaikurnai in relation to management of the Appointed Land.

Appointed Land

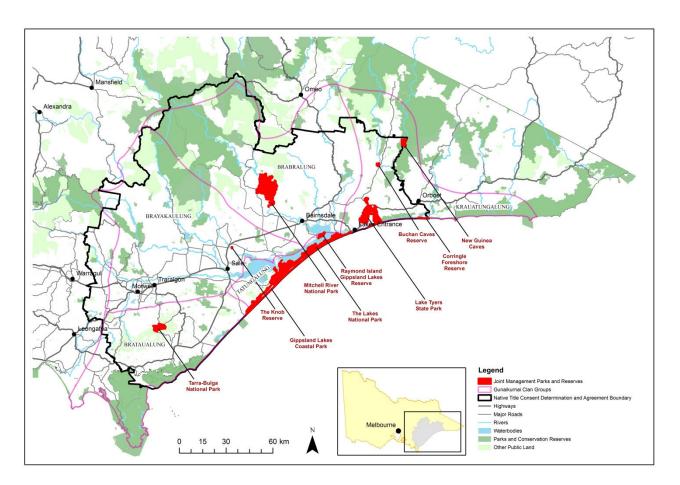


Figure 1: Map of Appointed Land (Joint Management with Aboriginal Title)

The Appointed Land of the Board (Figure 1.) comprises a combination of national and other parks and reserves, with a combined area of over 45,000 ha, and includes:

Under the terms of the *Gunaikurnai Recognition and Settlement Agreement*, Aboriginal Title is to be granted over all ten areas of the Appointed Land. Aboriginal Title is a grant of crown land to GLaWAC for the sole purpose of being jointly managed with the State. The Appointed Land will continue to be managed under the same legislation under which it is currently reserved, and Aboriginal Title will not affect existing use and access, which will continue to be managed under current legislation.

As at 30 June 2018, 9 of the 10 Appointed Land park/reserve areas above have been granted as Aboriginal Title. The remaining park (Gippsland Lakes Coastal Park) is due for transfer in 2018/19 following resolution of technical issues within the park.

Figure 1 below shows the location of the 10 parks and reserves comprising the Appointed Land in red, with the extent of the Gunaikurnai Native Title Consent Determination and Agreement area shown in black.

Objectives

The objective of the Board is to enable the knowledge and culture of the Gunaikurnai Traditional Owners of the Appointed Land to be recognised in the management of the land.

Functions

The functions of the Board are:

 to comment or make submissions on matters affecting or concerning the use or management of the Appointed Land;

- to prepare policies about the Board and its operation and engagement with external parties;
- those management functions that are conferred on the Board by agreement under any Act under which the Appointed Land is managed;
- those management functions that are delegated to the Board by a person or body who has those management functions in relation to the Appointed Land; and
- to carry out such other functions as are conferred on the Board by the Act or the Minister by notice published in the *Victoria Government Gazette*.

Powers

The powers of the Board include:

- to employ staff, including an Executive Officer to be responsible to the Board for implementing its decisions and carrying out its functions and duties
- to enter into arrangements or agreements with any other person or body for the carrying out of the Board's functions and duties
- to carry out works on the Appointed Land
- to delegate any of the Board's functions, powers or duties to a member of the Board or an employee of the Board; and
- to act as delegate or agent of a person or body who has management functions, powers or duties in relation to the Appointed Land when so appointed by that person or body.

Duties

The duties of the Board are:

- to prepare Joint Management Plans in relation to the Appointed Land
- to prepare subsequent plans at the time and in the manner specified in the Joint Management Plan
- to monitor and encourage compliance with and performance of the Joint Management Plan
- to take all reasonable steps to give effect to the Traditional Owner Land Management Agreement between the Gunaikurnai Land & Waters Aboriginal Corporation and the State of Victoria
- those duties conferred on the Board, by agreement or by or under the Act or any other Act, or are delegated to the Board; and
- to keep proper and full records of its proceedings.

1.4. ACHIEVEMENTS AND OPERATIONAL PERFORMANCE

The Board's performance throughout the reporting year continued to be guided by our Corporate Plan's strategic pillars. Annual work plans developed under these pillars continued to strategically guide the Board through the evolution of the Joint Management Plan, guide planning for implementation of joint management, support delivering a number of key joint management projects and build on board operating processes.

The Board's Corporate Plan strategic pillars are:

promoting the strategic direction and planning requirements for joint management;

- building the communication framework and relationships with our key partners, stakeholders and the public:
- **building capacity** within the Gunaikurnai people, JM Partners and the Board and **implementing joint management** through priority projects; and
- fostering and supporting **economic development** opportunities for Gunaikurnai people (including those to be identified through the joint management planning process).

During the reporting period, a number of initiatives and projects consistent with the Board's values and strategic direction were further progressed, designed, planned and/or implemented. These are a combination of the Board's key strategic task of preparing the draft JMP (including supplementary activities associated with this objective) and guiding joint management implementation. They include the development of joint management projects that complement the joint management planning process by contributing to capacity building, strengthening relationships and partnerships through implementation, while providing planning information and case studies that have been included in the draft JMP.

Planning

Planning activities associated with the completion of the draft JMP in order to progress to the development of the final JMP and planning for outcomes associated with the interim Knob Reserve Committee of Management and future JMP launch.

Strategic planning for finalising the JMP

- On-going JMP development and review using our existing contractors or engagement of specialists to undertake workshops with our JMP partners to finalise the draft JMP
- Amended the draft JMP in conjunction with our project partners following the two-month public consultation process
- Supported and coordinated a Project Coordination Group and Editing Committee to seek direction and endorsement by partners of actions required to finalise the draft JMP.

The draft JMP has been prepared with input from our development partners and outlines the proposed strategies and actions required for joint management of the Appointed Land as a partnership between the Gunaikurnai people and the State of Victoria. The aim is for the JMP to be a tool to contribute to the restoration of the Gunaikurnai people's ability to use, control, benefit from, and influence the development and management of their land.

The draft JMP consists of an overarching Joint Management Strategic Plan and 10 individual park plans, and identifies actions that will enable the Gunaikurnai people to:

- Use their land for spiritual, cultural, recreational and business purposes
- Regain their ability to influence and make decisions on how Gunaikurnai land is used and managed
- Be actively involved in the management of their land through the protection of heritage sites, protection of the natural environment, the maintenance of built assets, and the control of future development
- Benefit from the use of their land through employment, the enjoyment of cultural practices, community development and though well-defined vocational pathways to tertiary education for young Gunaikurnai people.

Importantly, the draft JMP also provides opportunities for the State and Gunaikurnai people to further develop close partnerships to provide mutual economic, social and environmental benefits to the State, Gippsland and the Gunaikurnai people.

The Knob Reserve- The interim Committee of Management for the Knob Reserve was appointed in April 2016 to undertake a pilot of an alternate joint management governance arrangement for Aboriginal Title land managed under the *Crown Land (Reserves) Act* 1978.

In keeping with an earlier recommendation of the Board, the Committee was established to provide Gunaikurnai an opportunity to be a key decision maker, pending approval of the JMP.

The Committee comprises representatives from GLaWAC, the Board and DELWP with Gunaikurnai having the majority of representative members.

Through its membership on the Interim Knob Reserve Committee of Management, the Board maintained its oversight and continued to contribute to and support the Committee's strategic planning processes and to ensure alignment with the draft JMP. Additional key planning projects to facilitate effective management and decision-making by the Interim Knob Reserve Committee of Management were progressed or completed, including;

- vegetation mapping and condition assessment and associated works program; and
- the undertaking of a voluntary cultural heritage management plan.

The Board is pleased to report the Committee is now responsible for managing relationships with the Reserve's stakeholders, overseeing all projects being undertaken on the Reserve, governing any operations and activity occurring on the Reserve, assessing and issuing licenses for activity use, and managing the Committee's budget.

Achievements for the Committee's second year include:

Financial/Governance

- Members formally re-appointed by Regional Director, DELWP
- Executive support for minutes, meetings administration maintained
- Local traders maintained to supply cleaning/hardware/materials under account arrangements.

Project works

- Conducted a Voluntary Cultural Heritage Management Plan (VCHMP)
- Investigated cultural burning and planned burning for potential delivery in 2018/19
- Conducted a vegetation survey and condition assessment in conjunction with West Gippsland Catchment Management Authority (WGCMA)
- Conducted an ethnobotanical survey and bush food training with GLaWAC On-country Team
- Delivered a Threatened Species Initiative Program with: planting, fencing, pest plant and weed control works undertaken
- General reserve repairs and maintenance.

Tenure Management & Site usage

- Developed an interim booking system and uploaded it to the Board's website.
- Developed a standardised system for collection and assessment of Reserve use licences.

User Engagement

- Actively engaged with the Stratford Pony Club to create a formal lease area for their regular activities.
- Developed a Knob Reserve specific community engagement strategy and implemented some of its key actions to raise awareness about joint management and the role of the Committee.

Planning for the endorsement and launch of the approved JMP- To ensure the JMP launch is inclusive of all the partners and coordinated to ensure a positive outcome.

The Board supported the established a committee to begin to scope and coordinate the launch of the approved JMP.

Engagement

Communication and engagement is seen as an important role of the Board to ensure the JMP partners and the public are well informed of the JMP development and to ensure that the aspirations of the Gunaikurnai people are accurately conveyed.

Communication and Engagement Strategy

Throughout 2017/18 the strategy was a key to delivering the key messaging and articulating and establishing the most effective methods of communication for the development of the draft JMP, and for associated communication and engagement activities and collateral. It has provided guidance on the most effective communication and engagement practices for the day-to-day functions of the Board both in the lead up to and beyond formal approval of the JMP. The delivery of the integrated strategy has ensured all stakeholders and key user groups have been provided with a genuine opportunity to contribute to the draft JMP and facilitated cohesion and collaboration among the various partnering groups and suppliers by achieving the following communication and engagement goals:

Joint management

- To achieve a greater level of understanding among stakeholders and the general community about the purpose, principles and benefits of joint management
- To build and maintain public trust and confidence in the process being undertaken to develop, and eventually implement the JMP
- To genuinely encourage, receive and wherever possible accommodate input from the Gunaikurnai people, partnering organisations, key stakeholder groups and the broader community into the draft JMP
- To secure endorsement from the Gunaikurnai people, partnering organisations and key stakeholders on the key directions contained within the draft JMP
- To secure agreement to the draft JMP by the Secretary of DELWP
- To secure an ongoing shared commitment towards the successful collaborative implementation of the approved JMP from the Gunaikurnai people, partnering organisations and key stakeholders
- To promote the communities understanding of the Interim Knob Reserve Committee of Management.

Board

- To increase awareness and enhance clarity about the purpose, role and activities undertaken by the Board;
- To position and establish the Board as a trusted and respected partner among its stakeholders and the broader community.

Engagement activities for the year that progressed in accordance with our integrated communication and engagement strategy included:

- Implementing an integrated communication and engagement strategy to guide the twomonth public consultation process through to JMP completion and proposed launch
- Development of JMP summary material for distribution during the proposed JMP launch
- Undertaking communication and engagement with the Gunaikurnai community, key stakeholders and user groups to inform them of the opportunity to provide input into the draft JMP and to identify issues of interest to them to be included in its final development
- Reporting to the GLaWAC Board to seek opinion, provide updates, discuss the JMP planning process, and to agree on how the two Boards are to continue to work together to finalise the draft JMP, while also working within the provisions of the legislation and agreements.

- Undertaking open community information sessions for public and stakeholders to find out more about the draft JMP and how to provide feedback/submissions.
- Maintaining and updating the Board's website as an important medium for Board communications and information (see www.gunaikurnai.com.au) and providing a platform for stakeholder and community feedback on the draft JMP.
- Maintaining effective communication and relationship management with partners through regular meetings, workshops, and reports to Board meetings.
- Supporting the Knob Reserve Committee of Management with its communication and engagement requirements.

Capacity Building and Joint Management Implementation

Maintaining the Board's endeavours to seek continual improvement of its operating and delivery outcomes and to continue to promote opportunities for joint management implementation consistent with the draft JMP.

Capacity building activities for the reporting period included:

- Undertaking an Internal Audit of its risk management framework
- Maintaining the engagement of a Chief Finance and Accounting Officer (required under Direction 3.1.2 of the 2003 Standing Directions of the Minister for Finance)
- Extending the secondment of a Project Officer from the EGCMA for support to the Executive Officer and the Board
- Reviewing and amending the Board's Business Plan to ensure the document continues to guide the work program and strategic direction of the entity over the next year, especially as the JMP moves from development to implementation
- The Audit and Risk Committee undertaking a review of its Ministerial Standing Directions obligations under the Financial Management Compliance Framework (FMCF) and the implementation of its recommendations to reach full compliance, including the development of additional policies and procedures required as a public entity
- Providing support to develop and endorse an annual work program for the Gunaikurnai Joint Management Rangers which includes a range of activities and capacity building elements
- Convening regular quarterly Audit and Risk Committee meetings and monitoring our Risk Register to address issues identified in the 2016/17 management letter from the Victorian Auditor-General's Office
- Maintaining an Executive Committee to define and focus the strategic direction of the Board, to prioritise operational decisions and consider urgent matters which require decisions that cannot be deferred until the next scheduled meeting of the Board
- Establishment and coordination of a Strategic Advisory Group to collectively guide implementation of the approved JMP
- Providing ongoing support for the priority joint management implementation projects by financially supporting the projects to progress GLaWAC's joint management priorities.
 These projects provide the platform for meaningful engagement, project delivery,

relationship building, Gunaikurnai Joint Management Ranger capacity building and informing the content of the individual park plans within the draft JMP.

Joint Management implementation projects supported by the Board in the reporting period included:

Sperm Whale Head- Joint 'On-Ground' Project

The joint 'on ground' project developed in conjunction with Parks Victoria and GLaWAC was largely completed in the 2017/18 year. The project team has followed its project plan and completed the day visitor site upgrade with the GLaWAC Joint Management Rangers completing the interpretation totem poles with interpretive content, refurbishing the day use shelter, installing new walkways/paths, upgrading the toilet facility and providing picnic tables and chairs. Remaining funds will be used to develop interpretive signs along a short trail leading from the site. The project has been an excellent example of promoting the outcomes and benefits of joint management and the positive outcomes associated with this type of project.

Enabling GLaWAC Priority Joint Management Projects

The Board, GLaWAC and Parks Victoria progressed a number of identified and agreed upon priority joint management implementation projects in 2017/18. Parks Victoria developed detailed project plans which were endorsed and overseen by a Project Control Group consisting of Parks Victoria, GLaWAC and Board representatives. Implementation of these progressed while also supporting training and capacity building of GLaWAC joint management staff through the roll-out.

Progress to date on these projects includes:

1. Cultural Mapping Project

- Archaeological survey and report for Lake Tyers visitor nodes completed
- Anthropologist has started collating recorded historic information and planning for Gunaikurnai interviews underway.

2. Joint Managed Parks Signage Manual

• Draft signage manual developed and approval process mapped.

3. Lake Tyers Camping and Access Strategy

- Communications and Engagement Plan approved
- Engagement sessions with Gunaikurnai and broader Aboriginal community with regard to the strategy with drop in sessions held at Lake Tyers Trust, Drouin, Morwell, Sale and Orbost
- Next stage of engaging with broader community groups and stakeholders planned.

4. New Guinea Cave II Project

 Site management options developed from consultation and engagement with Gunaikurnai.

Economic Development

Fostering and supporting the economic development opportunities presented by the joint management of the Appointed Lands is a key objective of the Board.

To progress this objective, the Board has worked collaboratively with GLaWAC to progress their economic development strategy, which focuses on four areas central to economic development for the Gunaikurnai people: the context, the principles, the initiatives and the performance framework.

These elements aim to ensure a robust, achievable, realistic and measurable journey towards sustainable economic development and which will provide the foundational support to identify and

support the development of opportunities presented through the use and joint management of the Appointed Land.

1.5. KEY INITIATIVES AND PROJECTS COMMENCED IN 2017-18

Joint Management Implementation Plan

The Joint Management Implementation Priority and Resourcing Project was initiated by the Board to provide an opportunity for joint management partners to consider initial JMP implementation priorities and resourcing required to implement them following the approval of the JMP.

Its aim is to ascertain and reflect an agreed position between the joint management partners on the following:

- An agreed list of JMP priority delivery/implementation initiatives (including monitoring and evaluation tasks) that need to be continued, commenced and/or completed during the first 6 years following approval of the JMP
- 2. The ideal scheduling of these priority activities and actions over the 6 year period to ensure the strategic intent of the JMP is fulfilled
- 3. Which joint management partner will lead implementation of each priority activity/action, and which partners will collaborate in their implementation
- 4. Annual budget/resourcing estimates to undertake each of the priority activities/actions over the 6 year period to identify;
 - i) what can be delivered within existing work programs/budgets, and
 - ii) what actions will require additional resourcing.

JMP Strategic Advisory Group

A high level JMP Strategic Advisory Group comprising members representing GKTOLMB, DELWP, GLaWAC and Parks Victoria was established and coordinated by the Board. The Terms of Reference for this group was established to achieve high level partner JMP alignment and relationships, advise the Board on resolution of critical JMP issues and to ensure partner JMP commitment is maintained. The group aims to meet at least twice annually or in response to critical issues.

1.7. CURRENT YEAR FINANCIAL REVIEW

The Board is funded through the Department of Environment, Land, Water and Planning as part of the *Gunaikurnai Recognition and Settlement Agreement* with the State of Victoria dated 22 October 2010.

As anticipated in the Board's 2017/18 Corporate Plan, operating expenses decreased for the reporting period, particularly those related to project expenditure. This expenditure related to the review and further development of the draft JMP, and the initiation of a number of joint management projects which support joint management in action. The experience gained by undertaking joint management in practice is accelerating information exchange and capacity building and has informed the proposed strategies and actions in the draft JMP.

1.8. SIGNIFICANT CHANGES IN FINANCIAL POSITION

There were no significant matters which changed our financial position during the reporting period.

1.9. SIGNIFICANT CHANGES OR FACTORS AFFECTING PERFORMANCE

There were no significant changes or factors which affected our performance during the reporting period.

1.10. CAPITAL PROJECTS

The Board does not manage any capital projects.

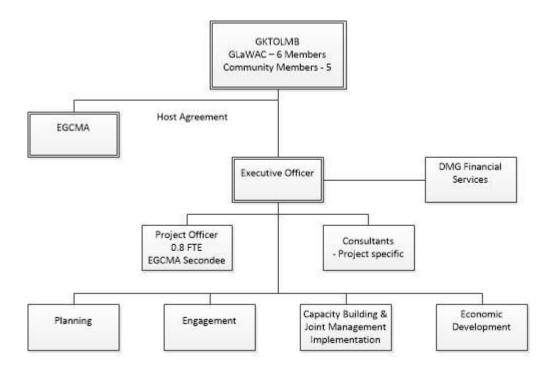

2.2 RELATIONSHIPS

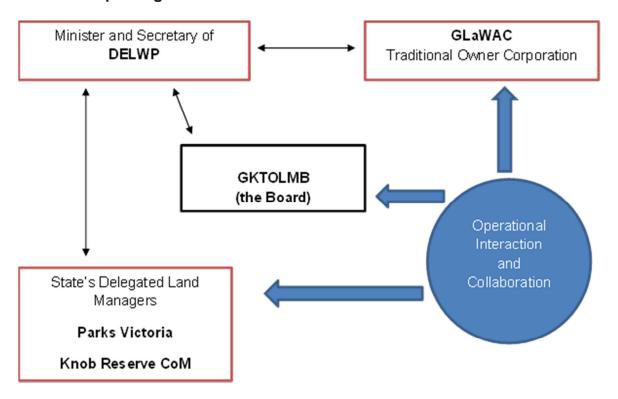
The following diagram illustrates the formal nature of the relationships that exist between the Board and its key partners in joint management, GLaWAC, Parks Victoria, and DELWP, along with its hosting relationship with the EGCMA.

As a joint management body, the development and maintenance of partner and stakeholder relationships is an integral part of the Board's work, and is essential for it to carry out its functions and duties effectively. The Board has actively encouraged GLaWAC, DELWP and Parks Victoria to participate in Board meetings and workshops. Structured reports are presented through standing agenda items at Board meetings where partner representatives are regular guests.

The Board identified a range of stakeholders and user groups who were consulted in the preparation of the draft JMP. The Board's Corporate Plan continues to identify actions aimed at building and strengthening these relationships throughout implementation of the approved JMP.

During 2017/18 the Board maintained its Hosting Agreement with the EGCMA. Through the Hosting Agreement, EGCMA provides to the Board a range of services and facilities associated with staff employment, office accommodation, equipment provision, and administration.

2.3 GOVERNING BOARD

The Board is responsible for:

- Developing and reviewing governance arrangements
- Developing strategies and effective working relationships with key partners
- Preparing a Joint Management Plan with the Secretary of DELWP, in consultation with the community that will enable the knowledge and culture of Gunaikurnai people to be recognised and incorporated into the joint management of the Appointed Lands
- Fostering capacity building and economic development opportunities for Gunaikurnai in relation to the management of the Appointed Land.

The Board has a broad skills base with considerable understanding and experience in corporate governance, Natural Resource Management Planning, land and water management, capacity building, Indigenous empowerment and business management.

The Gunaikurnai members of the Board have a strong connection to the Appointed Land and lifelong experience and knowledge of their cultural heritage.

The Board has adopted a Board Charter that guides the performance of its governance role and its operation and meeting procedures. The Charter also references the *Directors' Code of Conduct* issued by the Victorian Public Sector Commission.

Board composition

The Board consists of not more than eleven members appointed by the responsible Minister. Not less than six members are appointed by the Minister following nomination by GLaWAC. The Chairperson and Deputy Chairperson of the Board are appointed from among the members of the

Board by the Minister. The Chairperson is nominated by GLaWAC from among the members of the Board.

2.6 OCCUPATIONAL HEALTH AND SAFETY

The Board is committed to the pursuit of the highest possible health and safety standards in all of its workplace activities.

Given its hosting arrangement with the EGCMA, the Board has adopted, and works within, the EGCMA's systematic approach to integrating Occupational Health and Safety (OH&S) into our management and operational environments.

To this end, the Board's OH&S policy requires the staff who support the Board to adhere to the EGCMA's Work Health and Safety manual, safe work procedures, and training regime.

Basis of preparation

These financial statements are general purpose financial statements which have been prepared in accordance with the *Financial Management Act 1994* and applicable AASs, which include interpretations issued by the Australian Accounting Standards Board (AASB). They are presented in a manner consistent with the requirements of AASB 101 *Presentation of Financial Statements*.

The financial statements also comply with relevant Financial Reporting Directions (FRDs) issued by the Department of Treasury and Finance, and relevant Standing Directions (SDs) authorised by the Minister for Finance.

The Board is a not-for profit entity and therefore applies the additional Aus paragraphs applicable to "not-for-profit" Boards under the AASs.

The annual financial statements were authorised for issue by the Board on 4 October 2018.

(b) Reporting entity

The GKTOLMB is a Land Management Board of the State of Victoria, constituted by a determination made under the powers conferred by section 82B of the *Conservation, Forests and Lands Act 1987*.

(c) Basis of accounting preparation and measurement

Accounting policies are selected and applied in a manner which ensures that the resulting financial information satisfies the concepts of relevance and reliability, thereby ensuring that the substance of the underlying transactions or other events is reported.

The accounting policies set out below have been applied in preparing the financial statements for the year ended 30 June 2018, and the comparative information presented in these financial statements for the year ended 30 June 2017.

Items included in this financial report are measured using the currency of the primary economic environment in which GKTOLMB operates ('the functional currency'). The financial statements are presented in Australian dollars, which is the GKTOLMB's functional and presentation currency.

GKTOLMB's overall objective is to develop a Joint Management Plan for the 10 parks and reserves in Gippsland transferred to Aboriginal title.

Note 7: Risks, contingencies and valuation uncertainties

Categories of financial instruments

Loans and receivables

Loans and receivables are non-derivative financial assets with fixed or determinable payments that are not quoted in an active market. They are included in current assets, except for those with maturities greater than 12 months after the reporting date which are classified as non-current assets. Loans and receivables are included in trade and other receivables and other receivables in the balance sheet. Loans and receivables are recorded at amortised cost less impairment.

Financial liabilities at amortised cost

Financial instrument liabilities are initially recognised on the date they are originated. They are initially measured at fair value plus any directly attributable transaction costs. Subsequent to initial recognition, these financial instruments may be measured at amortised cost with any difference between the initial recognised amount and the redemption value being recognised in the comprehensive operating statement over the period of the interest-bearing liability, using the effective interest rate method. Financial instrument liabilities measured at amortised cost include all contractual payables.

Impairment of financial assets

At each reporting date, GKTOLMB assesses whether there is objective evidence that a financial instrument has been impaired. Impairment losses relating to loans and receivables are recognised in the Comprehensive Operating Statement.

(b) Credit Risk

Credit risk arises when there is the possibility of the Board's counter party defaulting on their contractual obligations resulting in financial loss to the Board. Credit risk is measured at fair value and is monitored on a regular basis.

Credit risk associated with the Board's contractual financial assets is minimal because the main debtor is the Victorian Government. For debtors other than the Government, it is the Board's policy to assess the credit worthiness of debtors. There are no contractual debtors at year end (2017: Nil).

In addition, the Board does not engage in hedging for its contractual financial assets and mainly obtains contractual financial assets that are on fixed interest, except for cash held on call at bank. The Board's policy is to only deal with banks with high credit ratings.

Provision for impairment for contractual financial assets is recognised when there is objective evidence that the Board will not be able to collect a receivable. Objective evidence includes financial difficulties of the debtor, default payments, debts that are more than 30 days overdue and changes in debtor credit ratings.

The carrying amount of contractual financial assets recorded in the financial statements, net of any allowances for losses, represents the Board's maximum exposure to credit risk without taking account of the value of any collateral obtained.

Credit quality of contractual financial assets that are either past due or impaired

There are no material financial assets which are individually determined to be impaired. Currently the Board does not hold any collateral as security nor credit enhancements relating to any of its financial assets.
