RE: NOTICE CONCERNING WORKS ON NATIVE TITLE LANDS (RIGHT TO COMMENT) PROPOSED CONSTRUCTION OF WATER MONITORING SYSTEMS

The Proposal

The Regional Water Monitoring Partnership is seeking to install two new water monitoring stations on the Tarra River at Pound Road East and the Agnes River at Agnes River Road to assess the water quality effects of inflows into Corner Inlet.

West Gippsland Catchment Management Authority are investigating what is happening to catchment loads of nutrients and sediment as a result of land practice change in the catchments that flow into Corner Inlet.

The proposed works will include:

- Tarra River The installation of an instrumentation cabinet with an underground conduit running between the cabinet and the waterway. There will also be a cable installed across the waterway to help collect high flow data which will require a single steel post with a pulley system installed on either site of the waterway above the highwater level and the two posts connected by a steel cable.
- Agnes River The installation of an instrumentation cabinet with an underground conduit running between the cabinet and the waterway.

Upon completion of the works, these sites will be inspected every two months to ensure the infrastructure is well maintained and that the instrumentation is collecting data of a high quality.

Seeking Your Comments

The *Native Title Act 1993* (NTA) requires DEECA to consult and seek comments from the Traditional Owners of Native Title lands and incorporate appropriate conditions into consent to use and develop the land.

We understand that the proponent may also be obliged under Cultural Heritage legislation to contact the Gunaikurnai RAP body concerning this project and we will advise them of those responsibilities as a matter of standard process. However, if you would also like DELWP to raise some specific conditions on cultural heritage protection matters in the exercise of your native title right to protect cultural heritage as part of this formal commentary and approvals process, we will be happy to do so at your direction.

Further, your comments on how this proposal might affect your other native title rights and interests, and how that can be managed or addressed as part of this approvals process are also keenly sought.

These recognised rights and interests include the:

- right to have access to or enter and remain on the land and waters;
- right to use and enjoy the land and waters;
- right to take the resources of the land and waters for the purposes of satisfying personal, domestic or communal needs, but not for any commercial purposes;
- right to protect and maintain places and areas on the land and waters which are of importance according to Gunaikurnai traditional laws and customs;
- right to camp
- right to engage in cultural activities;
- right to engage in rituals and ceremonies;
- right to hold meetings and gatherings;



• right to teaching and learning about the physical, spiritual and cultural attributes of places and areas of importance.

Please note that the 'non-extinguishment' principle applies to these works and your native title rights will continue to exist over the site.

The Department intends to advise the proponent that the project can proceed after 40 days from the date of this notification have elapsed. We would appreciate the opportunity to discuss this proposal however in the meantime please contact Sarah Brown at the following details.

Legislative Basis for this Notice

The proposed works are valid under <u>Subdivision H</u> of the *Native Title Act 1993* (NTA) which allows for an 'authority' to be granted which relates to the management of water.

In instances where authority is to be granted in regards to management or regulation of water, it is necessary that formal procedural notice be given to any registered claimant and to any registered Representative Body extending the right to comment.

The non-extinguishment principle applies.




Cadastral Plan - Tarra River






Cadastral Plan – Agnes River




Site Plan – Tarra River






Site Plan – Agnes River
